



### Contract of Agreement

This contract stipulates entertainment services between the undersigned PURCHASER referred to hereafter as such and POLLO LOCO, an Independent Contractor.

1. VENUE: The Paradise Center, Paradise, Montana
2. DATES: January 11<sup>th</sup> 2025
3. START: TBD (Performance duration (90-120 min) to be determined at a later date)
4. FINISH: TBD
5. PRICE: \$2,500.00 (payable in Cash, Check or Money order to Jeff Christiansen at the conclusion of the performance)
6. Accommodations: n/a
7. Sound and Lights provided by -POLLO LOCO
8. It is agreed that POLLO LOCO may distribute and sell recordings and other promotional items on the premises.
9. It is agreed by PURCHASER to provide POLLO LOCO Support Staff with free admission to event.
10. Stage area for outdoor shows shall be covered. If inclement weather is a possibility, adequate coverage (tarps, etc.) shall be provided by PURCHASER to cover equipment.
11. POLLO LOCO shall have the right to refuse to perform if water is standing on stage or otherwise deems playing conditions unsafe. Inclement weather rendering the performance unsafe or infeasible shall require 50% payment made to POLLO LOCO if PURCHASER has not made prior arrangements for safe/sheltered facilities.
12. It is agreed that either party hereto may cancel this engagement without penalty by giving written notice thereof at least 30 days prior to the commencement of this engagement. Cancellation by PURCHASER of less than 30 days advance notice shall be subject to a 50% cancellation fee from PURCHASER payable to POLLO LOCO.
13. The performance will be cancelled (or rescheduled)" due to the occurrence of any of the following:
  - a.) Death or sickness of any member of POLLO LOCO or their family members, accidents, riots, strikes, acts of God, accidents or mechanical failure of transportation or any other event beyond their control rendering performance impractical.
  - b.) Damage to PURCHASER'S performance facilities or infrastructure rendering the venue unsafe or unusable.

If a performance is rendered infeasible by either party due to the above conditions, it is understood and agreed there shall be no claim for damages and both parties' obligations shall be waived.


